

I am a solutions consultant with Ricoh Canada and have been with the organization for almost 25 years. I have been a residence of Kelowna, British Columbia for almost all of my life.

Beyond my professional life I had been involved with PowderHounds Adaptive Snowsports (Big White Ski Resort) for 13 years and for 7 of those years I served as the Director expanding the program from just 25 volunteers to 50 plus volunteers. During my tenure as director I also expanded the client base for PowderHounds Adaptive Snowsports increased by over 100 per cent and we went from zero CADS certified instructors and volunteers to over 50 per year.

Along with the CADS board members I was also instrumental in adding a fund developer to our program who is responsible for securing national funding allowing us to expand our programs and services to our clients as well as help support other common initiatives.

I also served as President of People in Motion for 6 years serving on a board of directors for 8 years..... looking over adaptive programs such as Wheelchair Basketball, Power Soccer, Adaptive Snowsports and a Transportation program
